I understand that LADWP has no obligations to the customer with respect to services provided by the Aggregator's Organization.

I understand that LADWP's approval of this application does not mean the Aggregator's Organization is enrolled in DSGS. The Aggregator's Organization must also complete all DSGS Provider Application Requirements and Processes.

I also understand that any permission to participate in the Program will expire on the same year as permission was granted. I understand that I must reapply for permission to participate in the Program for subsequent years.
